# Waverley Woollahra Art School Printmaking Prize 2022 - Terms and Conditions

#### 1. Eligibility

Waverley Woollahra Art School (WWAS) Printmaking Prize is open to anyone 16 years and over. Employees and Board Members of WWAS are not eligible to enter. Entries must be an original work by the artist. All printmaking techniques both traditional and digital are encouraged. Entries close midnight Friday 29 July 2022

### 2. Prizes (non-acquisitive)

Digital Printmaking Prize: \$1000Traditional Printmaking Prize: \$1000

### 3. Artwork Specifications

The exhibition for the WWAS Printmaking Prize will take place online. Please ensure you send a high resolution JPG image that can be used for a web based exhibition with your entry. 30 finalists will feature in the online exhibition (includes 15 finalists from each of the 2 categories). Printed size should not exceed A3 (42cm x 29.5cm).

#### 4. How to Enter

Entries open Friday 3 June and close at midnight on Friday 29 July. To enter the WWAS Printmaking Prize, entrants must complete the online form, to be found at <a href="https://www.wwas.org.au">www.wwas.org.au</a>, and upload a digital image of each artwork along with payment of the entry fee per artwork. Entry fees are non-refundable. Each artwork must be submitted as JPEG format and less than 2MB in file size per image. Each image must follow the naming convention: last name - first name - title - technique - dimensions in cm

#### 5. Entry Fee

A fee of \$35 per entry (inc gst) must be paid at the time of submission of the online entry form by following the link to payment located on the digital entry form. A maximum of 3 artwork entries per artist is allowed.

#### 6. Judges

Two Judges, independent of WWAS, will select 30 finalists from which two winners will be chosen (one winner per category). A highly Commended award will also be awarded for each category.

#### 7. Process of Selection

All finalists will be included in the online exhibition. The judges' decision is final and no correspondence or dispute will be entered into by the judges or WWAS.

#### 8. Announcement of Finalists

Finalists will be notified by email by Friday 26 August 2022 after which, all finalists will be announced at www.wwas.org.au/printmaking-prize-2022/ and via social media channels.

### 9. Requirements of Finalists

Finalists selected for the WWAS Printmaking Prize must provide an artist statement (up to 150 words) about their selected artwork by email once notified.

# 10. Announcement of Winners

Winners of the WWAS Printmaking Prize will be announced on Friday 2 September 2022.

#### 11. Reproduction of Images

WWAS reserves the right to use the digital images of artworks entered into the prize for the purposes of publicity, documentation and catalogues in paper, digital and electronic formats. WWAS will make appropriate acknowledgements.

# 12. Privacy

Personal information collected will only be used for the purposes of the Printmaking Prize or WWAS promotion and will be held by the administration staff of WWAS.

### 13. Ownership

Entries must not be the property of a third party. If an artwork is being entered by a commercial gallery or agent, the artist must give their permission.

# 14. Sale of Artworks

Finalists can sell their work during the online exhibition between 26 August to 23 September. WWAS will take a 30% commission for all artworks sold. The sale price on the entry form must remain fixed throughout the exhibition and should include the commission and GST (if applicable). If works are not for sale, select NFS on the entry form.

### 15. Exhibition Period

Finalists for the exhibition will be displayed online and may remain online as part of the archive of WWAS Printmaking Prize finalists for 2022.

### 16. Contact

By entering the WWAS Printmaking Prize you will automatically receive updates about the Prize and WWAS news. You can choose to unsubscribe by email correspondence at any time.

## 17. Dispute

In the event of a dispute regarding the interpretation of these terms and conditions, the decision of WWAS will be binding on all parties.
